

Dear Student,

Welcome to the University of Chicago from all of us at UChicago Student Wellness.

We are excited to meet you this Autumn and introduce you to the services and programs we offer to address your medical, mental health and overall wellness during your time at the University of Chicago.

This message is specifically to remind you about the University and State of Illinois immunization requirement for all incoming students.

Key points in this message:

- The deadline to submit immunization documentation is Friday, October 24.
- Upload your immunization documentation via the <u>my.WellnessPortal</u>.
- For students who need additional immunizations, there will be Immunization Clinics at Student Wellness starting in August 2025.

The University and the Illinois Department of Public Health (IDPH) require all incoming students enrolled in higher education institutions to provide proof of immunity against Measles (Rubeola), Rubella (German Measles), Mumps, TD (Tetanus and Diphtheria), and Meningococcal (under age 22). Students are encouraged to submit proof of immunization at least 30 days before classes begin on campus to avoid class registration holds in future quarters.

For students starting their studies in Autumn Quarter 2025, the deadline to submit immunization documentation is Friday, October 24. If you miss this deadline, a hold will be placed on your account, which will prevent you from registering for future courses.

To complete the immunization requirements for the 2025-26 academic year, you must follow the steps below.

Immunization Record Instructions

- Gather acceptable forms of documentation. This includes healthcare provider records, school immunization records, clinic/hospital records, International Certificate of Vaccinations, or other official documentation of your vaccination history. Please make sure that the record is in English; translations of non-English documents must be certified.
- 2. Log in to the <u>my.WellnessPortal</u> (<u>uchicagoportal.pointnclick.com</u>) using your CNET ID and password.
- 3. Click on Medical Clearances from the left-hand menu. Here you will provide the dates you received your immunizations AND upload your completed documentation. New Autumn students will be able to begin uploading documentation the first week of August.

It will take 7-14 business days for your immunization records to be reviewed. Once your records have been verified, you will see a green check mark and "compliant" next to the immunization. If further action is required, a secure message will be sent to your @uchicago.edu email and can be viewed in the Messages section of the my.WellnessPortal.

Need a required immunization? You may schedule an appointment at one of the Student Wellness Immunization Clinics that will take place from August-October 2025. Scheduling information will be released closer to the date.
