Why teach during the summer?



- Expand your teaching experience
- Experiment pedagogically
- Earn extra service income (if on a 9-month appointment and otherwise eligible)



Who takes Summer Quarter and September Term courses?

- College students
- Precollege students
- Visiting undergraduates
- Graduate students





Summer Quarter Undergraduate Courses

Open to **College students**(including incoming firstyears in some cases), visiting
undergrads, and select rising
high school seniors

Taught online

(taught in person if pedagogically necessary)

Core / General Education or major/minor requirements

 Especially if these are oversubscribed during the rest of the year

3, 5, or 8 weeks long (always at least 27 total contact hours)

Courses meet for different sessions
 June 10 – August 16, 2024 (no classes June 19 and July 4)

Consider **evening** meeting times for students with internships or jobs



September Term Undergraduate Courses

2024 will be the third year the College has an official September Term.

The response from students has been enthusiastic, with the number of courses offered more than doubling from the first to the second year!

Open to 2nd, 3rd, and 4th year College students only

May be taught online or in person

Focus on student outcomes: graduate in a timely fashion, springboard into AY courses or projects, unique opportunities

3 weeks long (for at least 27 total contact hours): August 26 – September 13, 2024 (no classes September 2)



Summer Session Precollege Courses

Designed specifically for high school students ready to tackle undergraduate-level work

- Global student body, vetted by College Admissions
- Officially enrolled, receive letter grade
- Labs, field trips, guest lectures, group projects

Mostly **in-person**, with a few online or hybrid courses

- In-person classes meet 9 a.m. to 3 p.m. with lunch break 11:30 am to 1 pm
- Online classes meet morning or evening

3-week in-person, 3-week hybrid, or 5-week online format

- In-person: Monday, June 17 Friday, July 5 (no class June 19 or July 4) OR Wednesday, July 10 Friday, July 26
- Hybrid: Wednesday, July 10 Friday, July 26 (July 10-19 online, July 22-26 in-person)
- Online: Wednesday, July 10 Friday, August 9




Precollege Student Experience
